## Quarry Bank Fishery (5 acre)

A very private and secure 5 acre lake nestled in 14 acres of natural beauty.

### Swims:

There's a choice of 4 swims; 1 x double swim, 1 x single swim, 2 x single swims very close. Single party bookings only, there won't be mixed parties.

### Facilities:

24 hour hot water, various power points. Drying room with fridge and freezer, fully fitted oak beam kitchen, with pots and pans, cutlery, plates, hob, microwave, dining table, kettle and drinking water from the tap (the other sinks in the shower rooms etc, the water needs to be boiled before drinking). 2 x Matching luxury Jacuzzi shower rooms with hand basins and toilets. Barbecue area plus many different outdoor seating areas to relax and enjoy watching nature doing its thing.

### Cost Breakdown:

Overall Cost: £250 per person  
£125.00 Deposit payable within 10 days of booking.  
£125.00 Balance due 10 weeks before your holiday.  
(Book 5 and the 5th goes for free or £200 each = £1,000.00)  
£50.00 for a non-angling guest

## Quarry Bank Fishery – RULES

1. NO KILL FISHING POLICY – no exceptions.
2. No homemade boilies, only good quality branded fresh frozen or preservative free shelf life boilies to be used. We recommend Quest Baits and sell these on site.
3. Maximum of 3 rods fishing at any one time. No rods to be left unattended with lines in the water
4. Weigh slings, cradles, landing nets and tripods supplied. Please leave yours at home.
5. A suitable antiseptic must be used. Propolis types highly recommended as it adheres to the fish. Area needs to be dried before use of any type of antiseptic) If you don't have any, it can be purchased at the fishery before fishing.
6. Minimum 15lb Monofilament line in 0.40 mm and must be of high abrasion resistance.
7. No braid, lead core or any other type of leader and 20" minimum of rig tubing to be used at all times.
8. Barbless hooks only, no long shanks or bent hook patterns.
9. No bait boats allowed.
10. No nuts of any description.
11. No sacking of fish, if you are found in the possession of one you will be asked to leave immediately.
12. Alcohol may be consumed in moderation but other drugs are strictly prohibited.
13. No fixed leads, all leads must be able to eject, no back leads to be used.
14. No swimming or entering the lake. Don't tamper with the life buoys; they are there for your own safety.
15. No carp pellet or particle allowed unless purchased on site.
16. Lake boat is for emergency use only (snagged fish or tackle). You must contact Neil or Lin who will take you out and a lifejacket must be worn.
17. No rubbish to be left in swims, please use the bins provided.
18. Do not use the bankside as a toilet. If seen doing so you will be asked to leave without a refund.
19. No fires, fishing stoves only. Cigarette ends to be safely extinguished and put in the bin provided.
20. Management reserve the right to inspect rigs and equipment to check they are safe.
21. Please drive with consideration through the village.
22. The gates to be locked at all times. No entry or exit after dark. If you need to get out please arrange with Neil or Lin beforehand.
23. All cars to be parked in front of the office. Management reserve the right to check all vehicles before they leave the site.
24. Arrival time 12 noon Saturday and leave 10 am the following Saturday.
25. Sorry, no dogs allowed.

### Important notes on safety

Quarry Bank Fishery is not suitable for young children. Anyone under the age of 16 years must be supervised by a responsible adult at all times. No climbing on rocks or trees, they may be unstable. The lake is very deep in places, strictly no swimming or entering the water for any reason.

The banks and platforms can become slippery at times, please take care. Quarry Bank Fishery cannot be responsible for any accidents or injuries that may happen as a result of irresponsible behaviour.

### Fire Hazard

The area is tree lined and prone to be very dry during the summer months. Ensure all equipment involving any naked flames or spark is fully extinguished and stored safely when not in use. Ensure all cigarette ends are fully extinguished and disposed of in the bin provided.

Special note: We reserve the right to review and change these rules at any time. Contact us the week leading to your departure for any up-dates.

# Terms & Conditions

---

1. On receipt by us of your non-refundable deposit we will reserve your holiday. Your booking is taken to be confirmed and accepted in respect of all persons travelling when we despatch our written confirmation to the person signing the booking form.

2. Your completed booking form showing all clients must be signed and returned within 7 days. The person signing the booking form confirms that he/she has the authority of all other persons included in the holiday to make the booking on their behalf and that he/she has read and accepted these booking terms and conditions. The deposit is accepted as part payment towards the total cost of the holiday.

3a). The balance of the cost of the holiday must be paid no later than 10 weeks before departure, or as we may otherwise specify. If you book within 10 weeks of departure you must pay the total cost of your holiday at the time of booking.

3b). If unconditional payment of the balance is not received by us by the due date, we reserve the right to cancel your booking, forfeit any deposit made and levy a cancellation charge as though there had been a cancellation in accordance with paragraph 5.

4. The price of your holiday is fully guaranteed.

5. In the event you cancel your confirmed booking, it can only be accepted if it is in writing from the person who signed the booking form, and the following cancellation charges will apply:

More than 56 days	Deposit only
30 - 55 days	50% of total cost
less than 30 days	100% of total cost

6a). All passport, Visa and Health Certificate requirements are your responsibility and we accept no responsibility for any delay or expense incurred through any irregularity in your documents. All British holidaymakers should ensure that they hold a Full Ten Year British passport with a validity of at least 3 months beyond the travel date. Non British subjects should consult their Embassy for information on possible Visa requirements.

6b). We reserve the right immediately to terminate the services we are contractually obliged to provide to you if we, our employees or agents or any other appropriate person in authority in any place or on any vehicle or craft judge your behaviour to be likely to cause discomfort or harm to our other clients or any other person or property. If because of such behaviour you are prevented by our carrier from travelling, our contractual obligations under these conditions will terminate immediately. In either case any appropriate cancellation fee will apply and we will not be liable to you for any refund or compensation or any costs or damage which you may incur.

7. Force Majeure: We will not be liable for loss or delay occasioned by any of the following: Strikes, Riots, Political Unrest, Hostilities, War or threat of War, Terrorist Activity, Industrial Disputes, Fire, Flood, Technical/Weather problems to transport, Closure of Ports, Weather conditions or any other event(s) beyond our control.

8. Clients are required to have an appropriate Travel/Holiday Insurance Policy in force for the period of the holiday.

9. Whenever possible, any changes to the booking requested after the written confirmation of booking is sent out to you will be accommodated. Dependant upon the nature of the changes, additional costs could be incurred.

10. The holiday booked cannot be assigned. Only the persons shown on the booking form are permitted to travel. Pets are not permitted.

11. Jurisdiction: Signature of the booking form constitutes acceptance of a contract on these terms subject to British Law and the exclusive jurisdiction of the British Courts.

12. Complaints Procedure: If you consider that you have cause for complaint whilst on holiday, the complaint should be notified, in the first instance, to the on site owner. In most cases, problems can be resolved if this procedure is followed.
