## Etang Du Vaulaurent (26 acre)

For those anglers after a little more luxury than just simple bivvy angling, there are two swims with their own cabins which can be booked as well as a larger, more luxurious cabin set slightly back from the water's edge for those wishing to make their holiday more of a family affair.

With carp to 72 lb and lots of large back up fish, this really is a big fish paradise. Arrive pm Saturday, Leave noon the following Saturday.

### Swims:

This 26 acre lake has just 8 swims which have to be chosen when you book. All of them offer lots of room and of those 8 swims 6 are doubles. The depths vary from 1.5 metre to 3.5 at its deepest with no major drop offs.

### Facilities:

Toilets & Showers Clubhouse with a sitting area, fridges, freezers, a microwave, a coffee maker, Wifi, hob and a sink for the anglers use. 2 person chalet and 4 Berth Chalet. Weekly Food Package Available

# Etang Du Vaulaurent – RULES

---

Please read these rules carefully before your trip to Vaulaurent. Failure to adhere to any of the following may result in eviction from the lake without any refund or compensation.

## A – LAKE

1. A Morbihan (Southern Brittany) federal fishing permit or an inter-federal permit is required to fish at Vaulaurent. This is included in the price.
2. Both day and night fishing are allowed. Under no circumstances must any species be killed. NO KILL.
3. It is STRICTLY forbidden to retain fish. However, if you're on your own and you catch a 'trophy fish' (over 25kg/55lbs), we will allow retention in a retention sling for a few minutes whilst you call the manager to come down and help you. If the manager does not answer the phone or is not available, the fish must be released immediately. Transporting fish from Vaulaurent to another private or public water will become a police matter.
4. Only green or camo bivvies and brollies are to be used.
5. Excessive consumption of alcohol is forbidden. Any form of drugs are not allowed.
6. You must vacate your swim by 10 am on the last day of your trip.
7. Visitors are allowed from 9am – 9pm during the summer, and from 9am – 7pm in the winter.
8. No swimming in the lake.
9. Vaulaurent is not responsible in the event of any theft or damage to your personal belongings, equipment or vehicles.
10. For your own safety, we reserve the right at any time to temporarily suspend either fishing, or putting up bivvies (e.g. a red alert from Météo France for severe storms, heavy rain, extreme heat, snow, thunder, etc). This also applies for unanticipated weather events.

## B – FISHING

1. One angler per swim with a maximum of 4 rods.
2. If two anglers are sharing a swim, there are to be no more than 6 rods in total.
3. Rods must not be left unattended under any circumstances. (swim 6 is set on a pontoon, a receiver for your bite alarms is mandatory.)
4. Each swim has a designated fishing area. In the case of a dispute between two parties, the manager will decide.
5. Cradles and slings are provided on each swim please do not bring your own. There are also weighing posts in each swim.
6. Please have Antiseptic (Steri-7, Medicarp, etc.) which must be used when and where necessary.
7. Boots and/or waders are essential to safely release fish.
8. Have a bucket of water ready at all times read for when you land a fish.
9. Fish are to be out of the water for as short a time as possible. Once a photo is taken, the fish must be released immediately. As per rule A-3, sacking is prohibited.
10. Coated Braided hook links are allowed.
11. No braided main line or lead core allowed
12. No lead-core safe zone leaders.
13. Single, micro-barbed and barbless hooks only (sizes 4, 6 or 8).
14. All particles must be prepared and cooked properly.
15. Strictly no tiger nuts.
16. Use of personal rowing boats and Zodiacs are strictly forbidden. Rowing boats are available for rent on swims 1 and 2 and are for daytime use only. Rowing boats are to be used for baiting up and dropping in lines. Use of personal

electric motors and echo sounders are permitted. Life jackets are mandatory.

17. Baitboats are allowed.

18. Baitboats can be hired on-site.

19. Any type of compressed air bait throwers are forbidden. Spods and similar are allowed in moderation.

20. Use of projector halogen lights are not permitted. For the comfort of other anglers.

### **C – PRACTICAL**

1. The use of the showers and toilets are free and must be kept clean.

2. Fridges, freezers, a microwave, a coffee maker, hob and a sink are available at the Club House. All of these must be cleaned after being used. WiFi is available at the Club House, password given on arrival.

3. English and French plugs are available in the Club House.

5. We sell Mainline and Urban Baits boilies, pop-ups and dips on-site (subject to availability).

6. After you have sent us your catch photos, they will then go on our Facebook page and website, so please let us know if you do not want yours published.

7. Once you have unloaded all of your gear, for swims 3, 4 and 5 your vehicle must be driven back to the provided car park. Exceptions can be made for disabled guests.

8. Each swim is equipped with a table and a barbecue (grill not supplied) (not to be used for campfires).

9. Each swim has a bin for general rubbish, and a bin for recycling.

10. All swims must be kept tidy.

11. You must not cut or destroy any of the plants or vegetation on or around the swims.

12. You must not destroy any part of the swims (e.g. dig up banks, dig holes)

Special note: We reserve the right to review and change these rules at any time. Contact us the week leading to your departure for any up-dates.

## **Terms & Conditions**

---

1. On receipt by us of your non-refundable deposit we will reserve your holiday. Your booking is taken to be confirmed and accepted in respect of all persons travelling when we despatch our written confirmation to the person signing the booking form.

2. Your completed booking form showing all clients must be signed and returned within 7 days. The person signing the booking form confirms that he/she has the authority of all other persons included in the holiday to make the booking on their behalf and that he/she has read and accepted these booking terms and conditions. The deposit is accepted as part payment towards the total cost of the holiday.

3a). The balance of the cost of the holiday must be paid no later than 10 weeks before departure, or as we may otherwise specify. If you book within 10 weeks of departure you must pay the total cost of your holiday at the time of booking.

3b). If unconditional payment of the balance is not received by us by the due date, we reserve the right to cancel your booking, forfeit any deposit made and levy a cancellation charge as though there had been a cancellation in accordance with paragraph 5.

4. The price of your holiday is fully guaranteed.

5. In the event you cancel your confirmed booking, it can only be accepted if it is in writing from the person who signed the booking form, and the following cancellation charges will apply:

6a). All passport, Visa and Health Certificate requirements are your responsibility and we accept no responsibility for any delay or expense incurred through any irregularity in your documents. All British holidaymakers should ensure that they hold a Full Ten Year British passport with a validity of at least 3 months beyond the travel date. Non British subjects should consult their Embassy for

information on possible Visa requirements.

6b). We reserve the right immediately to terminate the services we are contractually obliged to provide to you if we, our employees or agents or any other appropriate person in authority in any place or on any vehicle or craft judge your behaviour to be likely to cause discomfort or harm to our other clients or any other person or property. If because of such behaviour you are prevented by our carrier from travelling, our contractual obligations under these conditions will terminate immediately. In either case any appropriate cancellation fee will apply and we will not be liable to you for any refund or compensation or any costs or damage which you may incur.

7. Force Majeure: We will not be liable for loss or delay occasioned by any of the following: Strikes, Riots, Political Unrest, Hostilities, War or threat of War, Terrorist Activity, Industrial Disputes, Fire, Flood, Technical/Weather problems to transport, Closure of Ports, Weather conditions or any other event(s) beyond our control.

8. Clients are required to have an appropriate Travel/Holiday Insurance Policy in force for the period of the holiday.

9. Whenever possible, any changes to the booking requested after the written confirmation of booking is sent out to you will be accommodated. Dependant upon the nature of the changes, additional costs could be incurred.

10. The holiday booked cannot be assigned. Only the persons shown on the booking form are permitted to travel. Pets are not permitted.

11. Jurisdiction: Signature of the booking form constitutes acceptance of a contract on these terms subject to British Law and the exclusive jurisdiction of the British Courts.

12. Complaints Procedure: If you consider that you have cause for complaint whilst on holiday, the complaint should be notified, in the first instance, to the on site owner. In most cases, problems can be resolved if this procedure is followed.
